

What is in your component marks report March 2024 series

You will receive a component marks report containing a breakdown of all your candidates' marks for the series. The report does not include a breakdown of marks for candidates who have received 'PENDING' outcomes. The component marks report helps you and your teaching staff develop a deeper and more rounded understanding of your candidates' exam performance.

As part of our quality assurance process, when examiners have marked question papers we check the marks are fair, valid and all marked to the same standard.

The information in the report shows the journey a candidate's mark takes from the raw mark to the final mark. The only mark that is a confirmed judgement of a candidate's performance is the final mark.

Important information

There is a guidance section at the front of your component marks report explaining the different types of information it contains. This guidance is to help you better understand the information in the report. Please consider carefully how, and with whom, you share the component marks report.



Our component marks report:

- contains marks for each component of the syllabus for every candidate you have entered
- shows a raw, adjusted and final mark for each component, except for carried forward components for which only the final mark is shown
- is released on the Direct homepage and in the 'File Transfers' section of Direct by Monday 27 May 2024.

If you make an enquiry about results and your enquiry leads to a component mark change you can ask us to:

- update your component marks report
- provide an updated report for 'pending' outcomes once a grade is issued.

We can do one or both of the above as long as you do not have any other open enquiries for the same qualification.

If you wish to carry a changed component forward to the next series we advise you to ask us for a new component marks report. All open enquiries must be closed before we can issue an updated report. To ask us for an updated report email info@cambridgeinternational.org

We aim to upload all requested updated reports on a weekly basis (but occasionally this can take longer). We need to receive your request in writing to info@cambridgeinternational.org by 12:00 UTC/GMT on a Wednesday for the report to be uploaded by Friday of the same week. We will only provide component marks reports within 18 months of the results release date.

Do not ask us for component marks reports for a previous series near to the results release of a current series. We may take up to two weeks to process any requests we receive at these times.

Guide to types of mark and grade in the component marks report

Mark/grade	Description	Example		
Raw mark	The raw mark is the awarded mark by the examiner or marker for that component, which appears on the candidate's script. Raw marks are not displayed for components carried forward from a previous series. Due to quality assurance checks, more than one raw mark might be on a script. In these cases, the live mark is shown in this report.	18 out of a possible 40.		
Adjusted mark	Raw marks can be adjusted due to moderation, examiner scaling or special consideration. Where no adjustment applies, the raw and adjusted marks are the same. Adjusted marks are not displayed for components carried forward from a previous series.	19 out of a possible 40. (18 on the candidate's script, plus 1 to bring the mark in line with all other marking of the same paper; no special consideration sought or granted).		
Component grade	The component grade indicates the candidate's performance on that component, but is not used to determine the syllabus grade. The component grade is determined by comparing the adjusted mark to the component grade thresholds. A* is not available at component level.	Grade C for the component.		
Final mark	The final mark is the adjusted mark multiplied by the weighting factor for that component, where applicable. This makes sure that the component represents the correct proportion of the overall result. Where weighting is not required the final and adjusted marks are the same. Final marks that are not included in the syllabus total appear in brackets.	28.5 out of a possible 60. (18 on the script, plus 1 to give an adjusted mark of 19, multiplied by 1.5).		
Syllabus total	The syllabus total is the total of the final marks for the components that contributed to the overall result. You must ensure you are referring to the option containing the components that contributed to the final result when comparing the syllabus total mark to the option thresholds. Where there is more than one route to a result, the mark used will be the one that produces the best possible result.	95 out of a possible 200. (28.5 out of 60, plus marks on other paper(s) or coursework added up and compared to the maximum mark).		
Syllabus grade	The syllabus grade is the candidate's overall grade, produced by comparing the syllabus total mark to the option thresholds. A* is not available for Cambridge International AS Level.	Grade D because the candidate's syllabus total was 95 out of 200 and – in this case – we required at least 103 for a Grade C and at least 88 for a Grade D.
